Nursing Jurisprudence and Ethics

All nurses are required to complete at least two contact hours in nursing jurisprudence and ethics prior to the end of every third licensure renewal cycle.

The content must include information about the Texas Nursing Practice Act; the Texas Board of Nursing (BON) rules, including Board Rule 217.11; Standards of Nursing Practice; the Texas BON Position Statements; principles of nursing ethics; and professional boundaries.

Geriatric and Older Adult Care

All nurses who provide nursing care to any patient or patients who are older adults must complete at least two contact hours related to the older adult or geriatric care every licensure renewal cycle.

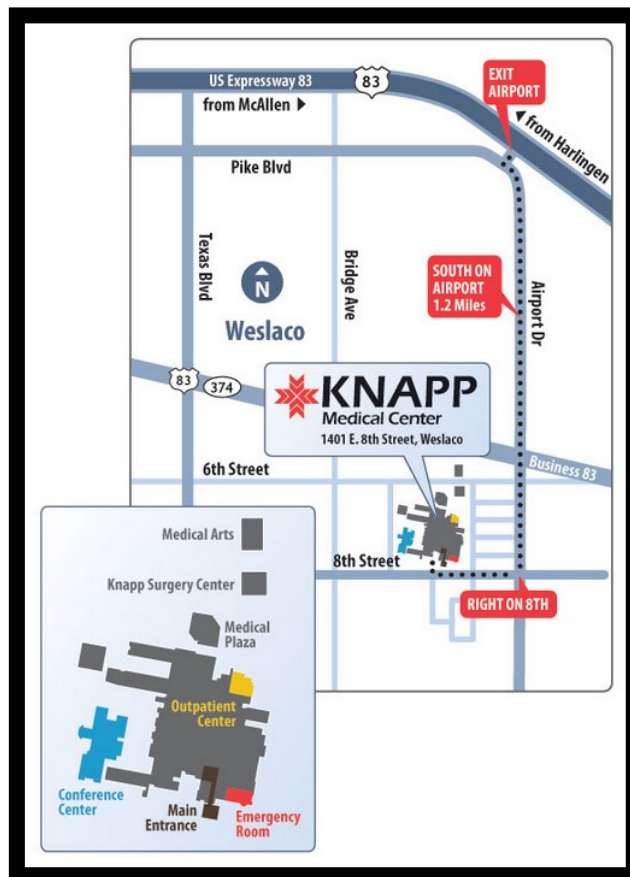
The content must include information about elder abuse, age related memory changes and disease processes, including chronic conditions, and end of life issues.
